**Grant of stock options**

Opsens’ Board of Directors also authorized the grant of a total of 200,000 stock options to M. Plamondon. Under the provisions of Opsens’ stock option plan, each stock option granted will entitle its holder to subscribe for one Opsens common share at a price of \$0.95 per share until April 15, 2012. Such options granted will be acquired over a period of four years at rate of 25 % per year, the first tranche being acquired at the end of the first year following the granting of the options.
